



This agreement is between  hereinafter referred to as **VENDOR**, and the **California CLETS Users Group**, located in the state of California, hereinafter referred to as **CCUG**.

This contract is for exhibiting items for personal sale on Thursday & Friday, September 13-14, 2012. Displays/exhibits can be set up as early as 7:00 a.m. on Thursday, September 13 and must be completed by 2:00 p.m. Friday, September 14, 2012.

- SINGLE: \$150 - includes 8' x 8' exhibit space with one six-foot draped table and two chairs**
- DOUBLE: \$200 - includes 8' x 16' exhibit space with two six-foot draped tables and four chairs**

In consideration of mutual agreements, covenants, promises, and stipulations, **VENDOR** and **CCUG** hereby simultaneously agree as follows:

1. **VENDOR** contracts to purchase exhibit/sales space for the 2012 CCUG Training & Technology Seminar to be held at the Crowne Plaza in Foster City, California.
  - a. **VENDOR** shall receive the use of one exhibit space (based on above selection). Vendor set-up will begin as early as one (1) hour prior to the contracted exhibit times.
  - b. Payment shall be made to **CCUG** and should accompany this agreement.
2. **VENDOR** shall hold harmless **CCUG** and its officers and/or agents from all liability, claims, issues, and demands including defense cost, whether resulting from court action or otherwise, arising out of acts, omissions, or events from participation in the CCUG Training & Technology Seminar.
3. This document fully expresses all agreements between **VENDOR** and **CCUG** with respect to the subject matter in this contract and shall constitute the total agreement of the parties for stated purposes. No alteration or addition to the terms of this agreement shall be valid unless made in writing and formally approved and executed by both parties.
4. This agreement supersedes all prior agreements entered into between the parties relating to said subject matter. Upon execution of this agreement, this document is effective and all prior agreements shall be null and void.
